The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 PM on 2019-04-23 at Siddha Kumakh Rural Municipality, Office of Rural Municipal Executive, Dhorchaur, Salyan. Bids must be valid for a period of 90(Ninety) days after bid opening and must be accompanied by a bid security (amount mentioned in above table) or scanned copy of the bid security in .pdf format in case of e-bid, which shall be valid for 30 days beyond the validity period of the bid.
